23 **COMPLAINT**

24 For its Complaint against Defendants Vibe Media, Inc., Alix Kari, and John Does #
25 1-5, Plaintiff MN Works, LLC (“MN Works”) complains and alleges as follows:

26 **I. NATURE OF ACTION**

27 This action arises from Defendants’ copying the constituent elements, including the
28 look and feel, of Plaintiff MN Works’ inherently distinctive website in violation of federal
 statutes and common law.

1 Since the time MN Works launched its Slixia website, located on the World Wide
2 Web at <slixia.com>, it has attracted thousands of users from competitor websites. Sensing
3 the tides of change, one of MN Works' main competitors, Defendant Vibe Media, Inc., the
4 operator of <cityvibe.com>, changed the layout of its CityVibe website to mimic many, and
5 in some cases all, of the aesthetic features on the Slixia website. Defendant Alix Kari is the
6 President of Vibe Media.

7 The inherently distinctive layout of the Slixia website incorporates elements of
8 simplicity, stylishness, and navigational ease. Advertisements displayed on the Slixia
9 website are personalized by each entertainer and displayed in a proprietary format
10 developed by MN Works. Instead of using bland, text-based advertising format, each
11 webpage is customized by the entertainer but made to look professionally designed by
12 using the proprietary format developed by MN Works.

13 Plaintiff's success in attracting advertisers and entertainers to its website has clearly
14 caught the attention of its competitors, including but not limited to Defendants. However,
15 unlike Plaintiff's other competitors, Defendants have reacted to Plaintiff's success by
16 stealing Plaintiff's website design and copying it. Plaintiff has filed this action to stop
17 Defendants from engaging in the theft of Plaintiff's intellectual property and profiting off of
18 it. Defendants' theft of Plaintiff's intellectual property is particularly troubling because
19 Defendants' CityVibe website is far more established in the adult entertainment industry,
20 leading Plaintiff to believe that Defendants will attempt to mislead the public into believing
21 that Plaintiff stole Defendants' intellectual property or is somehow affiliated with
22 Defendants, when in fact Defendants stole Plaintiff's intellectual property. Defendants are
23 using unlawful methods in an effort to extinguish Plaintiff as a competitor while stealing
24 the innovations that Plaintiff is bringing to the industry. Plaintiff MN Works seeks to end
25 Defendants' unlawful activity to ensure that Internet users are not confused and that MN
26 Works' reputation is unharmed.

1 **II. JURISDICTION AND VENUE**

2 1. This is a civil action for violation of the Computer Fraud and Abuse Act (18
3 U.S.C. § 1030), the United States Lanham Act (15 U.S.C. § 1125 *et seq.*), common law
4 misappropriation, and civil conspiracy.

5 2. This Court has jurisdiction over claims involving the Computer Fraud and
6 Abuse Act and the Lanham Act pursuant to 28 U.S.C. § 1331 and has supplemental
7 jurisdiction over Plaintiff's remaining claims pursuant to 28 U.S.C. § 1367.

8 3. This Court has personal jurisdiction over Defendants because:

9 a. Defendants own and operate the CityVibe website, located on the
10 World Wide Web at <cityvibe.com>, which is accessible to Arizona residents.

11 b. Through the CityVibe website, Defendants regularly conduct business
12 in the State of Arizona. In fact, the CityVibe website has directories for 20 cities in
13 Arizona, and has listings for entertainers in 20 cities in the State of Arizona (*see* Front Page
14 of CityVibe.com, attached hereto as **Exhibit 1**). Within the last month, CityVibe has
15 advertised for at least 60 VIP entertainers and 89 non VIP entertainers in Phoenix alone.
16 (*see* CityVibe Listings for Phoenix, Arizona, attached hereto as **Exhibit 2**). Thousands of
17 adult entertainers in the State of Arizona have advertised on Defendants' CityVibe website
18 since its inception, and CityVibe clearly has availed itself of the advantages and privileges
19 of the marketplaces in Phoenix, Tucson, Flagstaff, and 17 other Arizona cities and towns.

20 c. Defendants committed tortious acts that they knew, or should have
21 known, would cause injury to Plaintiff in the State of Arizona.

22 4. Venue is proper in this Court pursuant to 28 U.S.C. §§ 1391(b) and (c).

23 **III. PARTIES**

24 5. Plaintiff MN Works is an Arizona limited liability company with its principal
25 place of business in Scottsdale, Arizona. Since April 11, 2011, it has owned the registration
26 for the <slixa.com> domain name and, since that time, registered the service mark for
27 SLIXA® with the United States Patent and Trademark Office.

28

1 6. Plaintiff MN Works is engaged in the business of operating an online adult
2 entertainment directory, which displays advertising for individuals to meet and connect
3 with entertainers.

4 7. The backbone of MN Works' business is online advertising. However, unlike
5 many of its competitors in the adult entertainment directory business, MN Works does not
6 accept third party advertisers or display advertising banners on the Slixia website.
7 Advertisers on MN Works are the entertainers themselves who agree to pay a fee to display
8 their advertisements on the Slixia website.

9 8. Upon information and belief, Defendant Vibe Media, Inc. ("Vibe Media") is a
10 California corporation, which does extensive business in Arizona.

11 9. Defendant Alix Kari is the President of Vibe Media.

12 10. Plaintiff has not yet fully and independently identified the true names and
13 capacities of Defendants sued herein as Does 1-5, inclusive, and therefore sues those
14 Defendants by fictitious names. Plaintiff reserves the right to amend this Complaint to
15 allege said Defendants true names and capacities when they are ascertained. Plaintiff is
16 informed and believes and thereupon alleges that each of the fictitiously designated
17 Defendants was a participant in the acts alleged herein, such that each is jointly and
18 severally responsible for the acts and omissions complained of herein.

19 **IV. ALLEGATIONS COMMON TO ALL COUNTS**

20 11. MN Works owns and licenses all of the content found on the Slixia website,
21 and operates the site.

22 12. MN Works is the owner of the rights in the trademark SLIXA, bearing
23 Registration Number 4,280,848 in the United States Patent and Trademark Office for
24 computer services, namely, providing a website for others to customize webpages in the
25 field of adult-themed services.

26 13. Plaintiff MN Works' Slixia website went live on the World Wide Web on or
27 about November 30, 2012.

28

1 14. The Slixia website operates as a directory for adult entertainers and permits
2 adult entertainers from many North American cities to advertise their services to interested
3 parties. (*See* Front Page of Slixia.com Website, attached hereto as **Exhibit 3**.)

4 15. Adult entertainers who sign up for the Slixia website are permitted to post
5 their own advertisements and are provided with live statistics that track the performance
6 and conversion rates of those advertisements. Entertainers' advertisements resemble
7 centerfold layouts in fashion magazines more closely than they resemble adult
8 entertainment advertisements on other adult entertainment directories, including the
9 CityVibe directory owned and operated by Defendants. (*See* Sample Entertainer Profile
10 and Sample VIP Entertainer Profile, attached hereto as **Exhibits 4 and 5**.)

11 16. Slixia's revolutionary format for entertainer advertisements has drawn
12 extremely positive reviews from adult entertainers, who have expressed a preference for
13 Slixia's advertising format over those of competing sites, including the CityVibe site
14 operated by Defendants.

15 17. The rapid emergence of Slixia as one of the preeminent directories for adult
16 entertainers has caused MN Works' competitors to take notice, particularly Defendants who
17 operate the widely known and well-established CityVibe adult entertainment directory.

18 18. MN Works has expended significant resources and gone to great effort to
19 create an adult entertainment directory that excels in creativity, functionality, originality,
20 and that provides entertainers and their customers with an optimal experience. Slixia's
21 preliminary success is attributed to the unique look and feel of its website and the
22 accompanying functionality to navigate the website.

23 19. Defendants VibeMedia and Alix Kari operate the CityVibe adult
24 entertainment directory, located on the World Wide Web at <cityvibe.com>.

25 20. Defendants' CityVibe website is one of the longest-running and most
26 established adult entertainment directories on the Internet.

27 21. Prior to the launch of Plaintiff's Slixia website, Defendants' CityVibe website
28 looked nothing like the Slixia website. Rather, it looked like a typical Internet directory that

1 contained advertisements and postings that all very closely resembled one another featuring
2 plain text and photographs provided by the entertainers advertising on the CityVibe
3 website. It additionally featured third party advertising, like virtually every adult
4 entertainment directory other than Plaintiff's Slixia website.

5 22. However, shortly the launch of the Slixia website, Defendants stole the format
6 and layout of Slixia's VIP entertainer profiles and began using a substantively identical
7 profile format for CityVibe's VIP entertainer profiles. (*See* Sample CityVibe VIP
8 Entertainer Profile, attached hereto as **Exhibit 6**.)

9 23. As time passes, Defendants regularly convert more of their advertisements,
10 particularly their VIP advertisements, to closely resemble the VIP advertisement style
11 developed by, and belonging to, Plaintiff MN Works.

12 24. The resemblance of CityVibe's VIP advertisements to those created by MN
13 Works for the Slixia website is not accidental. Prior to the launch of the Slixia website, no
14 adult entertainment directory had advertisements that resembled those created by MN
15 Works for Slixia, including CityVibe. However, shortly after the launch of Slixia,
16 CityVibe's VIP advertisements changed to mimic those created by MN Works for Slixia.

17 25. Specifically, the following features of CityVibe's VIP advertisements bear an
18 unmistakable resemblance to those created by MN Works:

19 a. CityVibe's VIP advertisements are now broken into content blocks,
20 exactly like the VIP advertisements created by MN Works for Slixia.

21 b. CityVibe incorporated similar textured page backgrounds on its
22 CityVibe site that MN Works developed for the Slixia website.

23 c. The diagonal VIP ribbon on CityVibe directory listings are in the exact
24 same location as they are on Slixia's page.

25 d. VIP advertisements for both Slixia and CityVibe feature a photograph
26 of the entertainer that takes up approximately the entire width of the page and the top
27 quarter of the length of the advertisement. No adult entertainment directory had used a
28 similar layout before it was developed by MN Works for Slixia.

1 e. CityVibe's new VIP entertainer listings now have the entertainer's
2 name overlaid on the full width photo on a semi-transparent background, as designed by
3 Plaintiff for its <slix.com> website.

4 f. MN Works developed a distinctive layout that includes the
5 entertainer's avatar with a quote inlaid below the avatar and a vertical bar to the left of the
6 quote. VIP advertisements for both Slix and CityVibe both feature contact and other
7 personal information for the entertainer on the right side of the advertisement listing in the
8 same or similar general format, color scheme, and font.

9 g. VIP advertisements for both Slix and CityVibe both feature a
10 description of the entertainer's interests and a link to "jump" to the entertainer's contact
11 information on the bottom left of the advertisement listing. The wording, positioning, and
12 functionality of this "jump" feature is exactly the same on CityVibe's new layout as the one
13 previously designed by Slix.

14 h. Photographs of the entertainer are laid out in the same spots on each
15 page in both the Slix and CityVibe advertisements.

16 i. Text describing the entertainer's services is laid out in the same
17 manner in both Slix and CityVibe advertisements, including slightly larger text in the
18 introductory first paragraph.

19 j. CityVibe has even copied the color scheme of the Slix
20 advertisements.

21 k. CityVibe's VIP advertisements no longer feature third party
22 advertisements, just as Slix's do not.

23 l. Entertainer incall and outcall notifications, as well as the "report this
24 profile" web button, are in the exact same position and feature the exact same wording on
25 the Slix and CityVibe sites.

26 m. CityVibe has recently added incall maps for its VIP entertainers that
27 are in the same location and style as those developed by MN Works for the Slix website.

28

1 Prior to the development of the Slixia website, CityVibe's VIP listings did not feature any
2 elements of this layout, but now co-opt Slixia's layout almost entirely. (*See generally*,
3 Comparison of Exhibits 5 and 6.)

4 26. Any differences between the Slixia and CityVibe VIP advertisements are
5 nominal. Most obviously, Slixia has more menu options in the header and footer of each
6 advertisement than CityVibe. However, this feature is arguably not even part of the
7 advertisements and does nothing to absolve CityVibe of stealing Slixia's VIP advertisement
8 design virtually whole cloth.

9 27. Defendants' behavior constitutes not only an unlawful act in and of itself, but
10 Defendants' willful disregard for Plaintiff's intellectual property rights has also resulted in
11 significant harm to Plaintiff MN Works. Defendants' copying of the Slixia website creates a
12 high likelihood that Internet users will believe that the services of Slixia and CityVibe are
13 related, when they are not, or that Slixia endorses CityVibe, which it does not.

14 28. Moreover, given that Defendants' CityVibe is an established adult
15 entertainment directory that is well-known in the adult industry and MN Works' Slixia
16 website is a new venture, Plaintiff MN Works faces the danger that consumers will believe
17 that MN Works has stolen Defendants' intellectual property, when the opposite is true.
18 Such assumptions by consumers could be devastating to MN Works while assisting
19 Defendants in extinguishing the business of MN Works as a competitor.

20 29. Indeed, Defendants' decision to steal MN Works' intellectual property is
21 hampering MN Works' ability to fairly establish Slixia as an industry competitor of
22 Defendants' CityVibe website.

23 30. On information and belief, Defendants have willfully and maliciously
24 engaged in unauthorized access to, and unauthorized appropriation of, MN Works' data,
25 information, computers, and computer systems and networks in an effort to copy MN
26 Works' Slixia website and to handicap MN Works' ability to emerge as a competitor of
27 Defendants.

28

1 31. Defendants have benefitted financially from their unlawful activity while
2 intentionally harming the business of MN Works.

3 32. Each of the Defendants had knowledge of the other Defendants' unlawful
4 actions and authorized and/or directed them to take the actions described in the Complaint
5 on the other Defendants' behalf.

6 **FIRST CLAIM FOR RELIEF**

7 **VIOLATION OF THE COMPUTER FRAUD AND ABUSE ACT (18 U.S.C. § 1030)**

8 33. MN Works repeats and realleges all preceding paragraphs as if set forth in
9 full herein.

10 34. Defendants knowingly and intentionally accessed MN Works' computers
11 without authorization or in excess of any authorization. Defendants were not authorized to
12 use MN Works' Slixia site or services for the purposes of copying its web pages, copying its
13 design, copying its features, and copying its trade dress. Defendants were also not
14 authorized to access MN Works' computer servers beyond the terms set forth in Slixia's
15 Terms and Conditions, which Defendants violated by (among other things) duplicating
16 content on the Slixia website without authorization.

17 35. After gaining unauthorized access to MN Works' servers, Defendants
18 obtained and used valuable information from MN Works' computers in transactions
19 involving an interstate communication.

20 36. Defendants knowingly, willfully, and with an intent to defraud accessed MN
21 Works' computers without authorization, or in excess of any authorization, and obtained
22 valuable information from MN Works' computers, which, on information and belief,
23 Defendants used to obtain something of value. Such valuable information includes, but is
24 not limited to, Slixia's webpage design and Internet user interface.

25 37. Defendants' conduct has caused MN Works to suffer losses far exceeding the
26 statutory minimum of \$5,000.00.

27
28

1 38. MN Works has suffered damages resulting from Defendants' infringing
2 conduct and seeks compensatory and punitive damages under 18 U.S.C. § 1030(g) in an
3 amount to be proven at trial.

4 39. By reason of Defendants' conduct, MN Works has suffered, is suffering, and
5 will continue to suffer irreparable harm. Unless Defendants are enjoined, the irreparable
6 harm to MN Works will continue. MN Works has no adequate remedy at law.

7 **SECOND CLAIM FOR RELIEF**

8 **TRADE DRESS INFRINGEMENT (15 U.S.C. § 1125)**

9 40. MN Works repeats and realleges all preceding paragraphs as if set forth in
10 full herein.

11 41. The unique look and feel of MN Works' Slixia website and services, including
12 its graphical user interface, constitute protectable trade dress.

13 42. The user interface of the Slixia website is unique, recognizable, and not
14 merely functional.

15 43. Defendants have copied the trade dress of the Slixia website in connection
16 with goods or services in commerce in a manner likely to confuse, deceive, or cause
17 mistake among Internet users as to the affiliation, connection, or association of Defendants'
18 CityVibe website with Plaintiff's Slixia website. Alternatively, Defendants have deceived
19 Internet users as to the origin, sponsorship, or approval of CityVibe's goods, services, or
20 commercial activities.

21 44. MN Works has been adversely affected by Defendants' violations. As a
22 direct and proximate cause of Defendants' violations, MN Works has been damaged in an
23 amount to be proven at trial.

24 45. By reason of Defendants' conduct, MN Works has suffered, is suffering, and
25 will continue to suffer irreparable harm. Unless Defendants are enjoined, such irreparable
26 harm will continue. MN Works has no adequate remedy at law.

27 46. On information and belief, Defendants' actions were willful and knowing,
28 entitling MN Works to aggravated damages pursuant to 15 U.S.C. § 7706(g)(3)(C).

THIRD CLAIM FOR RELIEF

5

COMMON LAW MISAPPROPRIATION

6

47. MN Works repeats and realleges all preceding paragraphs as if set forth in full herein.

8

48. MN Works has invested substantial time and money in the development of its trade dress and all other intellectual property inherent in the <slixa.com> website.

49. Defendants have unlawfully acquired and misappropriated Plaintiff's trade dress and other intellectual property at little or no cost, thereby causing injury to Plaintiff.

50. Plaintiff has suffered damages as a result of Defendants' misappropriation and is entitled to recover damages in an amount to be determined at trial.

FOURTH CLAIM FOR RELIEF

15

CIVIL CONSPIRACY

16

51. MN Works repeats and realleges all preceding paragraphs as if set forth in full herein.

18

52. A civil conspiracy exists where there is a formation and operation of a conspiracy, and the plaintiff suffers damage from an act or acts done in furtherance of the conspiracy's common design.

53. Defendants have formed and operated a conspiracy for the purpose of stealing or misappropriating MN Works' intellectual property.

54. MN Works has been harmed and suffered damages as a result of Defendants' conspiracy and is entitled to recover damages in an amount to be proven at trial.

V. REQUEST FOR RELIEF

26

Plaintiff respectfully requests relief as follows:

27

28

1 A. That Defendants and their agents, servants, employees, attorneys, affiliates,
2 distributors, and any other persons in active concert or participation with them be
3 preliminarily and permanently enjoined from:

4 a. Making any unauthorized use of, or gaining unauthorized access to, MN
5 Works' data, information, computers, computer systems, or computer
6 networks;

7 b. Accessing Slixia's data, information, computers, computer systems, or
8 network for any reason whatsoever;

9 c. Maintaining websites, including adult entertainer and adult entertainment
10 directory websites, that contain confusing or unlawfully copied material
11 from Plaintiff's trade dress on the Slixia website;

12 d. Using data or any other information obtained from MN Works via
13 improper means;

14 B. That Defendants be directed to file with the Court and serve upon Plaintiff's
15 counsel a report in writing and under oath setting forth the manner in form in which
16 Defendants have complied with the requirements of the injunction within 30 days after entry
17 of judgment;

18 C. That Defendants be directed to file with the Court and serve upon Plaintiff's
19 counsel a report in writing and under oath setting forth an accounting of any and all sales,
20 revenues, profit sharing or kick-back payments Defendants made, obtained, or distributed as
21 a result of their actions in violation of Plaintiff's rights described herein within 30 days of
22 entry of judgment;

23 D. For damages according to proof presented at trial, including liquidated and
24 statutory damages;

25 E. For disgorgement of any money, property, or the value of any other economic
26 benefit that Defendants received as a result of their unlawful conduct;

27 F. For aggravated damages;

28 G. For punitive damages;

- 1 H. For a reasonable royalty;
- 2 I. For interest as provided by law;
- 3 J. For costs of suit, including reasonable attorneys' fees; and
- 4 K. For such other relief as the Court deems just and proper.

5 **V. JURY TRIAL DEMANDED**

6 Plaintiff demands a jury trial on all claims that may be tried by jury.
